(*) Equity shares aggregating to 70,75,471 (Seventy Lakh Seventy Five Thousand Four Hundred and Seventy One) allotted to Future Corporate Resources Private Limited (FCRPL) on exercise of conversion option of entire 7,500 Compulsorily Convertible Debentures (CCDs) originally allotted on 12th December, 2019 shall be under lock - in accordance with Regulation 167 of the SEBI (ICDR) Regulations, 2018. Further, out of 70,75,471 equity shares, 30,00,000 Equity Shares were allotted on 11th February, 2020 pursuant to conversion of 3,180 CCDs, 27,50,000 Equity Shares were allotted on 16th January, 2021 pursuant to conversion of 2,915 CCDs and remaining 13,25,471 Equity Shares were allotted on 27th May, 2021 pursuant to conversion of 1,405 CCDs (listed on both the stock exchanges i.e BSE Limited (BSE) and National Stock Exchange of India Limited (NSE)). On August 30, 2022, 7,33,735 Equity Shares got released from lock-in and as on the date only 63,41,736 Equity Shares are under lock-in.
