Further the name of Suhani Trading and Investment Consultants Private Limited was changed to Future Corporate Resources Private Limited with effect from 11th December, 2018.

Further, out of 70,75,471 equity shares, 30,00,000 Equity Shares were alloted on 11th February, 2020 pursuant to conversion of 3,180 CCDs( listed on both the stock exchanges i.e BSE Limited (BSE) and National Stock Exchange of India Limited (NSE) ), 27,50,000 Equity Shares were alloted on 16th January, 2021 pursuant to conversion of 2,915 CCDs and remaining 13,25,471 Equity Shares were alloted on 27th May, 2021 pursuant to conversion of 1,405 CCDs.
