There is further to our intimation dated April 18, 2021 giving intimation of petition filed under section 9 of Insolvency and Bankruptcy Code, 2016 ('Code') by M/s. We had last intimated that the said matter was listed on October 09, 2023, in Court No. 5, NCLT, Mumbai for consideration but it was not taken up and was adjourned to November 23, 2023. We further intimate that the matter was listed today i.e., 23.11.2023 before Bench 5 of the Hon'ble NCLT, Mumbai and the Hon'ble Bench directed that, since this matter was argued in length before the earlier bench therefore, this matter shall not be re-heard, and the final order will be passed. The matter will be listed for pronouncement of order as and when the order is ready and shall subsequently be available on the NCLT portal.
